DO'S & DON'T'S

All Exhibitors must Strictly Adhere to the following Rules & Regulations:

- 1. **SMOKING IS STRICTLY PROHIBITED** in the Rooms, including the Toilets and the Entire Exhibition Area.
- 2. All Floors are Strictly "Non Smoking Floors".
- 3. PHOTOGRAPHY IS STRICTLY PROHIBITED in the Entire Exhibition Area.

- 4. Any Person Below The Age Of 18 Years Will Strictly Not Be Permitted To Enter The Fair Area Or Undertake Any Work.
- 5. Garments / Textiles brought into the Exhibition Area will not be permitted to be taken outside the Hotel till the end of the Fair.
- 6. Gutkhas, Cigarettes, Liquors, Glasses, Agarbati, Candles, Cello-tapes etc. are strictly not allowed in the Fair Venue and the same shall be confiscated on the spot.
- 7. Exhibitors cannot keep any Furniture, Display Material, Mannequins, and Standees etc. outside the Allotted Rooms / Stall or in the Passage Way.
- 8. Sticking of Posters or any other Material on Walls, Doors & Furniture is strictly not Permitted.
- 9. No Carpentry Work, Polishing Or Painting In The Allotted Rooms Or In The Entire Hotel. Any Use Of Thermocol, Cotton, Grass Etc. Or any Inflammable Material Will Not Be Permitted Inside The Allotted Rooms / Stalls.
- 10. Drilling on The Floor, Column, Walls Or Any Other Part Of The Room is Strictly Prohibited and the same Will Be removed Immediately. The Cost of the Damage caused will be adjusted from the Security Deposit.
- 11. Soft Music Will Be Permitted In The Allotted Rooms Provided It Does Not Disturb / Cause Any Inconvenience To The Fellow Exhibitors. The Association Reserves The Right To Ask The Exhibitor To Stop Playing The Music If It Receives Any Complaint Of Disturbance / Causing Inconvenience To The Fellow Exhibitors.

The Decision of the Fair Sub-Committee in respect of all aspects of the Organization of the Fair will be Final and Binding on All Participants.
