- (i) Draw of Lots Function for Vendor Sourcing Fair (VSF) was held in the Office of the Association on 1st November 2021.
- (ii) Meeting of the Office Bearers of the Association was held on 8th November 2021.

- **c.** The Association further made an alternate Recommendation on 30th November 2021 to the PMO, Hon'ble Finance Hon'ble Ministers of Finance, Textiles, Secretaries of the Concerned Ministers, Members of the GST Council and Hon'ble Chief Ministers of various States to consider the said Recommendations.
- d. The Association also sent a Press Release for the Launching of Arbitration Cell on 23rd November 2021 at Yogi Sabhagruh through a P R Agency.
