- The Association launched the CMAI FAB Show on 6th December 2021 in the SRK Hall of The (iv) Southern Gujarat Chamber of Commerce and Industry, Surat for the benefit of probable Exhibitors and Members of SGCCI.

REPRESENTATIONS & PRESS RELEASE: i)

- On 20th December 2021 and 23rd December 2021, The Association sent Media Reports, Pictures of Protests and Objections from various sections of the people on the proposed increase of GST to 12% on Textiles and Garments to the PMO, Hon'ble Ministers of Finance, Textiles, Secretaries of the Concerned Ministers, GST Council Secretariat, State Finance Ministers, Hon'ble Chief Ministers of various States & requested them to review the decision.
- On 30th December 2021 the Association wrote to State Finance Ministers, who are Members of b. the GST Council including, Hon'ble Chief Ministers of various States & requested them to support the industry by ensuring that the increase is not implemented in the GST Council Meeting to be held on 31st December 2021.
- On 31st December after the decision taken by the GST Council at its Meeting to defer the C. proposed increase in GST Rates on Textiles, the Association sent Letter of Thanks to the Prime Minister, the Hon'ble Minister of Finance, Hon'ble Minister of Textiles, Secretaries of the Concerned Ministers, GST Council Secretariat, State Finance Ministers, and Hon'ble Chief Ministers of various States.
