Mr Rajesh Masand, President has invited Mr Ashish Gujarati, President, The Southern Gujarat Chamber of Commerce & Industry, Surat, as Special Invitee to the Managing Committee of the Association for the Year 2022-2022.

4. REPRESENTATION ON CITI

Mr Rajesh Masand, President, CMAI has accepted an Invitation from Confederation of Indian Textile Industry (CITI) to be an Invitee to the Committee of CITI during 2021-22.

5. **MEETINGS/EVENTS/SEMINARS:**

- (i) Mr. Rajesh Masand, President, CMAI attended a virtual meeting on 4th January 2022 with Shri. Piyush Goyal, Hon'ble Minister of Textiles & Smt. Darshana Jardosh, Hon'ble Minister of State for Textiles along with approx. 100 Associations across the country to enforce the Government to continue with the current GST Rates in the long term and not merely as a short term Deferment.
- (ii) The 8th Meeting (Zoom) of the Managing Committee of the Association was held on 5th January 2022.
- The 3rd Meeting (Zoom) of the Retail Co-operative Sub Committee of the Association (iii) was held on 12th January 2022.
- The 4th Meeting of the Conciliation & Arbitration Sub-Committee was held on (iv) 22nd January 2022.

6. REPRESENTATIONS & PRESS RELEASE:

- The Association has sent a reminder to the Governor, Reserve Bank of India to give clear (i) instructions to the Banks and Financial Institutions not to insist for an additional charge since the additional credits has already been guaranteed by the Govt. under the Emergency Credit Line Guarantee Scheme (ECLG Scheme) to ease the flow of credit to the MSME Units.
- The Association has sent a request for an Appointment with Shri Basavraj Bommai, (ii) Hon'ble Chief Minister of Karnataka, Govt of Karnataka, Bengaluru, who is heading the Core Group of Ministers Nominated to study the Entire Issue of Inverted Duty Structure in various Industries and a possible Rate Rationalisation, to present a Report of A T Kearney Consulting India Pvt Ltd, who prepared an analysis the Import of various GST Rates on the Textile Industry on behalf of the Association.
- The Association also requested American Apparel and Footwear Association (AAFA), (iii) U.S.A to wait for the initial verdict from the Hon'ble Court with regard to Buyers expectation of payment of Variable Dearness Allowance (VDA) in the State of Karnataka.
