Welcome to the The CMAI'S 2nd FAB Show. All Exhibitors are requested to Strictly follow the Do's & Don't's at the Fair:

IMPORTANT

All Exhibitors are requested to wear the Face Mask at all times, maintain Social Distancing during Fair and Minimize all possible Physical Contact with the Service Providers, Buyers & Business Visitors. Please Sanitize your Hands from time to time.

DO'S & DON'T'S

1. The Fair Timing will be from 10.00 A.M to 8.00 P.M. for all Three Days.
2. **SMOKING IS STRICTLY PROHIBITED** in the Entire Exhibition Area, including the Cafeteria & Toilets.
3. **PHOTOGRAPHY & VIDEOGRAPHY ARE STRICTLY PROHIBITED** in the Entire Exhibition Area.
4. **ANY PERSON BELOW THE AGE OF 18 YEARS WILL STRICTLY NOT BE PERMITTED TO ENTER THE FAIR AREA OR UNDERTAKE ANY WORK.**
5. **Fabric Material / Garments / Textiles / Garment Accessories** brought into the Exhibition Area will not be permitted to be taken outside the Exhibition Hall till the end of the Fair.
6. The Maximum Height permissible for **Stalls in Shell Scheme will be 8 Feet to maintain Uniformity.**
7. All Bare Space Stall need to Submit the Technical Stall Design for Approval by 12th September 2022. Kindly Submit the Design to services@cmai.in. Please note that Stall Possession will not be given to the Exhibitors, without Approval from the organizer.
8. **For Stalls in Bare Space (Above 35 SQM) the Maximum Height permissible will be 3.5 mtrs. for the frontage & all other walls will be 2.5 mtrs to maintain uniformity**
9. All Bare Space Stands must have 1 suitable type of Fire Extinguisher in the stall.








10. **All Bare Space Stalls Fabricators should strictly wear Safety Shoes & Helmets during the Setup and Dismantle Days. All staff working at a height of 1.8 Mtr. from ground level should wear rated full-body harness and same should be anchored to an appropriate anchored point.**
11. **All Bare Space Stalls need to Provide 1 Mtr. Access Ramp (Inside the stall) for Specially Abled people.**
12. **All temporary electrical installations fitted in the stand shall be installed by a trained and licensed electrician of the approved contractors and operated in compliance with the latest statutory regulations. The cables used must be as per statutory codes, bare electric leads and crocodile clips are not allowed. All wiring must be protected against short circuits and overloading. No open joints will be allowed. Wooden junction boxes and switchboards are strictly not allowed at the event venue.**
13. **Stall Fabricators have to lay a carpet in the exhibition hall below all areas where stands structure/panels/brandings/installations/speakers/counter / barricading are being placed.**
14. **All the Materials used in the Construction of the Stall shall be Non-Combustible, Non-Flammable. Artificial Plants, Flowers, Grass will not be allowed to Decorate the Stall. Uses of Fire-retardant Spray is Mandatory.**
15. **No suspension or hanging display will be permitted from the Trusses or the Air Condition Ducts of the Exhibition Halls. Similarly, no fittings or display will be permitted to be Nailed, Screwed, or Drilled onto the floor, column, wall, or any other part of the Exhibition Hall. The same will be removed immediately and the Exhibitor will be Penalised for the damage caused to the Property.**
16. **No Carpentry or Painting work will allow other than the Allotted Stall Area.**
17. **No Empties, Stall Construction Materials will be allowed outside the Stall Area.**
18. **Exhibitors can install their own Lights but FLOODLIGHTS AND HALOGEN LIGHTS ARE STRICTLY NOT ALLOWED in the Stalls as they are Hazardous and reduce the effectiveness of Air Conditioning thereby causing inconvenience to all.**
19. **Outside Food & Beverages (including Mineral water) is Strictly Prohibited.**
20. **Chewing of tobacco, eating paan, chewing gum, gutkha, pan masala, washing hand inside the hall or on the stand area, littering, and spitting is strictly prohibited in the event venue.**
21. **Admission of any animals, birds or pets into Jio World Convention Centre premises is prohibited.**



22. **The use of the following vehicles inside the buildings is not permitted. This includes Scooters, Segway, E-Scooters, Bicycles Etc.**
23. **Remote-controlled flying objects within the event venue are not permitted.**
24. **Use of Firecrackers is strictly prohibited within the Jio World Convention Centre.**
25. **Nothing should be parked / leaned against the wall.**

The Decision of the FAB Sub-Committee in respect of all aspects of the Organization of the Fair will be Final and Binding on All Participants.
