This is further to our Circular No 28 /68th IIGF / 22 dated 12th October 2022 announcing that the 68th India International Garment Fair (IIGF) Autumn/Winter 2023-24 will be held from 07 - 09 February 2023 at India Exposition Mart, Greater Noida.
