3. MEETINGS / EVENTS

- a) A joint Meeting of Members, Board of Trustees and the Elected Members to the Managing Committee of the Association for the Years 2022-23 & 2023-24 met twice during the month under review in connection with Selling off / Leasing out of the lying vacant and Unutilised Premises of the Association at 313, Adhyaru Industrial Estate, Sun Mill Compound, Lower Parel, Mumbai 400 013 . The Members of the Board of Trustees and the Elected Members to the Managing Committee have unanimously decided to give the Premises on Leave & License to Mr Pradip Gala of M/s Leelaveera , Andheri (West) for 11 Months on a License Fee of Rs.90,000/- per month w.e.f 1st November 2022.
- b) The Members of the Managing Committee organised an Off Site Meeting at Radisson Spa & Resorts, Lonavla from 9th -11th October 2022 and discussed the future activities of the Association and required structural changes to achieve these goals.
- c) The Fair Sub Committee met on 17th October 2022 under the Chairmanship of Mr Rohit Munjal, and decided to organise the 76th National Garment Fair on the 31st January 2023 , 1st February & 2nd February 2023 at NSE Complex, Goregaon (East) Mumbai 400 063. The Association has received an Overwhelming response towards Participation in this Fair.
- d) The Vendor Sourcing Sub Committee also met informally and reviewed the Organising of the 2nd Vendor Sourcing Fair on the 24th & 25th November 2022 at JIO World Convention Centre, Bandra Kurla Complex, Bandra (East) Mumbai 400 098.
- e) The Conciliation & Arbitration Sub Committee met on 20th October 2022 under the Chairmanship of Mr Nirav Sanghavi, and Reviewed the current working of the Sub Committee, Strategies for Improving Collections, Pending Cases pertaining to the disputes between the Members and Retailers etc.

The Association has announced the CMAI Arbitration Panel consisting of 11 Members from the Trade and Eminent Legal Expertise.
