
#### 3. MEETINGS / EVENTS

- a.) The Office Bearers of the Association met on 9<sup>th</sup> November 2022 and the Members of the Managing Committee on 16th November 2022 and discussed and decided matters pertaining to the Activities of the Association. They are as under :

  - (ii) CMAI'S APPAREL TRAINING CENTRE, BHIWANDI The Association had earlier decided to set up an Apparel Training Centre at Asmeeta Texpa, Bhiwandi in 2019-20. However, due to the Covid Pandemic we were unable to start the Training Centre. The Association now felt that it is imperative to fastrack the starting of the CMAI 's Apparel Training Centre. Accordingly, Mr Mansukh NIshar of M/s Sangam Dresses (Brand- VITAMIN) who has already set up his factory at Asmeeta Texpa, has been appointed as the Chairman of the Training Centre to kick start the Training Centre.
  - (iii) 1<sup>ST</sup> NORTH INDIA GARMENT FAIR IN MAY 2023 Due to the demand by Members as well as non-Members based in Delhi and its surroundings, the Association has decided to Organise the 1<sup>st</sup> North India Garment Fair for the benefit of Members based in Delhi, NCR Region, Punjab, Haryana & Rajasthan. The details of the said Fair are being worked out by the Association and the same will be intimated to the Members soon.
