Thank You to the Department of Consumer Affairs for consideration of Industry's request. The efforts of CMAI, RAI, CITI and other leading Associations, has finally borne fruits and a Bill has been introduced to decriminalise certain Acts - the most important for our Industry being the Legal Metrology Act.
