3. MEETINGS / EVENTS / REPRESENTATIONS

The Office Bearers of the Association met on 12th January 2023 and the Members of the Managing Committee also met on 12th January 2023 and discussed and decided matters pertaining to the Activities of the Association including increasing of Membership, Organising of North India Garment Fair, 3rd CMAI FAB Show & Brands of India Show at Dubai.

As advised by the Members of the Managing Committee, the Association has sent a LAST & FINAL REMINDER to those Members whose Membership Subscriptions are due for the current Financial Year with a request to remit the same by 31st January 2023 failing which the Association will be compelled to Stop Rendering Services and such Members shall ceased to be a Member of the Association.

We have also sent a List of Members area wise to the concerned Members of the Managing Committee, who had voluntarily agreed to approach the Members in their respective Industrial Estates / Area to pursue the Members to pay the Subscription.

We have made a Representation to Smt Roop Rashi, IA & AS, Textile Commissioner, Ministry of Textiles, Govt of India on 16th January 2023 requesting her to Recommend / Support Handloom & Handicraft Sector in CMAI 3rd FAB Show with their active Participation.

We have also made a Representation on 16th January 2023 to Shri Sandeep Kumar, IAS, Commissioner, Micro, Small & Medium Enterprises, Office of MSME Commissionerate, Gandhinagar, Gujarat requesting him to support the Association under MSME for 3rd CMAI FAB Show for Participation from Gujarat

Similarly, we have also made a Representation ON 18TH January 2023 to Dr Rahul Gupta, Commissioner of Industries, Govt of Gujarat, Gandhinagar, requesting the Govt to extend the stall subsidy support under the MDA Scheme (other State) for Exhibitors in the 3rd CMAI FAB Show.

Mr Naveen Sainani, Chairman, FAB Sub Committee, Dr Ajoy Bhattacharya, Chairman, Southern Gujarat Regional Adhoc Committee and Mr Rahul Mehta, Chief Mentor of the Association met Shri Balvantsinh Rajput, Hon'ble minister of Industries, Govt of Gujarat on 28th January 2023 and appraised him about the 3rd CMAI FAB Show and also invited him personally to attend the 3rd CMAI FAB Show in April 2023 in Mumbai.

We have further made a Strong Representation to Smt Nirmala Sitharaman, Hon'ble Minister of Finance, Ministry of Finance, Govt of India bringing to her attention the plight of our Members in connection with the financial crises which has hit the well known Future Lifestyle Fashions Ltd, a part of the Future Group and requesting her to intervene and resolve by timely assistance of the Banking Sector, which has the potential to cause irreparable damage to the entire Garment Industry, resulting in a loss of Crores of Rupees and Thousands of Jobs and also would result in further crash of many of the MSME Business which are wholly dependent on the Future Lifestyle Fashions Ltd.

We have made a Representation on 16th January 2023 to the Managing Director, Maharashtra State Co-Op Bank Ltd, informing them that the Members of the Association are eager to establish a Cooperative on the basis of the Feasibility Study conducted by the Association and also requesting the Bank to extend assistance in establishing a Cooperative.

We have also made a request on 24th January 2023 to Shri Uday Samant, Hon'ble Minister of Industries, Govt of Maharashtra, requesting the Ministry to Nominate Mr Ankur Gadia, Chairman, State Govt Liaison Sub Committee, and Mr Dinesh Nandu, Jt Chairman, State Govt Liaison Sub Committee to the Advisory Committee of the Ministry of Industries, Govt of Maharashtra to play a wider role in the overall development of Industrial Activity in Maharashtra.

4. CMAI SIGNS MOU WITH SOFT, PUNE

The Association has signed an Memorandum of Understanding (MOU) with MKSSS's School of Fashion Technology (SOFT) Pune on 20th January 2023 for collaboration, coordination and Co-operation between the two leading Institutions of the Garment Industry. The MOU envisages mutual co operation in Recruitment, Training Field visits for Students and Academic exposure to the Industry's Entrepreneurs and Practitioners. This is the first time the Association tied up with an Educational Institution in the Garment Industry.

5. 76TH NATIONAL GARMENT FAIR

The 76th National Garment Fair was held on 30th,31st January 2023 & 1sat February 2023 at the Bombay Exhibition Centre, NSE Complex, Goregaon (East) Mumbai 400 063.

The Fair was Inaugurated by Shri Chandrakant (Dada) Patil, Hon'ble Minister of State for Textiles, Govt of Maharashtra, Mumbai.

859 Exhibitors (937 Stalls) representing 1071 Brands showcased their latest Spring / Summer Collections 2023 covering a Gross Area of Approx. 6,00,000 Sq Ft , participated in this Fair. Approx. 17,000 Trade Visitors visited this 3 Day Fair. This was the largest Spring / Summer Apparel Trade Show organised by the Association. The Exhibitors and the Retailers were extremely satisfied with the arrangements and the Business conducted at the Fair.
