NEW TEXTILE POLICY OF GOVT OF MAHARASHTRA

The Government of Maharashtra announced the Integrated and Sustainable Textile Policy for 2023-2028.. The salient features pf the Policy for the next 5 Years includes Processing Capacity of Cotton from 30% to 80%, Investment of INR 25000 Crore and Employment generation upto 5 Lakhs, To encourage participation of women at all levels of management in the textile industry, Skill Development and capacity building, Development of 6 Technical Textile Parks in the State, Capital and Electricity Subsidy, Space on Rent at MIDCs outside Mumbai.
