REPRESENTATIONS

The Ministry of Textiles, Govt of India requested the Association to send its view on the demand of Sri Lanka to increase Duty Free Exports to India from 8 million pieces to 75 million pieces. The Association has strongly insisted that there is absolutely no cause to allow any increase for the following reasons:

- 1. Domestic Industry going through its worst patch in decades
- 2. Imports from Bangladesh have gone up by nearly 450% from 2015-16 thanks to duty free agreement; Imports from Sri Lanka have gone up by close to 150% even under the current regime it will follow Bangladesh example if we allow unfettered imports;
- Allowing such large quantities will only open up imports of Chinese fabrics;
- 4. Main products imported from Sri Lanka already being manufactured in India (Undergarments, Trousers, Shorts) so there is no advantage to be gained.
