The Team also learnt of the Legal and Quasi-Legal Remedies available to the Manufacturers for Recovery of Dues like NCLT, Summary Suit/Commercial Suit, Arbitration, MSME Samadhan Portal, Criminal Suit U/S 138 Of Negotiable Instrument Act, their process, advantages and disadvantages, Limitations etc.
